- 4. Liquor auctioned at the event cannot be served or consumed at the event.
- 5. An auction may be advertised and the advertisement may mention liquor brands and/or manufacturers. AGCO's prior approval is not required; however, the applicant must comply with all regulatory requirements. Please visit the AGCO website for more information on the Liquor Advertising Guidelines (**www.agco.ca**).
- 6. A notice must be posted at the event stating that alcohol may not have been tested by the LCBO.
- 7. The auction event organizer (to whom the authorization is issued) must obtain sign off from the purchaser of any alcohol sold by way of auction that they acknowledge the alcohol may not have been tested.
- 8. Records must be kept by event organizer for six (6) months after the auction date and provided to the Registrar upon request.
- 9. Homemade wine/beer cannot be auctioned.
- 10. Manufacturers and licensees may not donate liquor to be auctioned.
- 11. Auctions must take place at a physical location that has been approved by the Registrar.
