The information on this form is collected pursuant to the *Liquor Licence Act*, R.S.O. 1990, Chapter L19 and/or the *Liquor Control Act*, R.S.O 1990, C.L.18. I understand that the Alcohol and Gaming Commission of Ontario ("AGCO") intends that the principal purpose for which this information will be used is to consider my application for a liquor licence under the *Liquor Licence Act* and/or authorization under the *Liquor Control Act*.

#### Consent

I CONSENT to the AGCO collecting such additional information about me as may be necessary for the AGCO to verify the information contained on my application.
