Café Thuy Ky Karaoke & Bar, North York	Overcrowding; service outside prescribed hours; failure to clear signs of service	60 days
City Nightclub, Toronto	Permitted drunkenness; overcrowding; breach of condition of the establishment's liquor licence	30 days
Cow and Sow Eatery (The), Fenelon Falls	Encouraged immoderate consumption	30 days
Esperado, North York	Breach of condition of the establishment's liquor licence	22 days
Firehall (The), Waterloo	Serving minors; failure to inspect identification; overcrowding; permitted drunkenness; encourage immoderate consumption; failure to clear signs of service; carried on business under a name other than the name set out on the licence; failure to prominently post proper form of Fetal Alcohol Spectrum Disorder warning sign	40 days
