Yesterdays' first race involving Rafael Hernandez, Luis Contreras and David Moran for interference at the top of the stretch. Rafael said they had the extra gate parked in the Quarter mile shoot on the main track and he saw it and ducked away. It cost him the race because the horse came off the bit and we lost momentum. Luis said he ducked out in front of him and caused him to check his horse. David said the same, one of those things, his horse ducked and we were in the way. After review we decided it was not the fault of Rafael and he did do his best to correct the issue quickly. No action taken.
