Jockey Agent Steve Roberts informed us that Jockey Chris Husbands will be off his mounts today.

Jockey Agents Neal Wilson, (Luis Contreras) and Gary Kemplen (Jerome Lermyte) provided a copy of the calls in the condition book for their respective Jockeys they are now representing.

Trainer Harold Ladouceur called to ask if we had spoken with Jockey Luis Contreras regarding Love and Laugh in the 8th race yesterday. Horse was eased through the stretch and the Official Veterinarian observed the horse and relayed that the Jockey had stated he eased the horse because the saddle had slipped. Will speak with Mr. Contreras later today.

Jockey Pierre Mailhot excused from his mount today in the 2nd race.

Spoke with Luis Contreras and he confirmed that his saddle had slipped on Love and Laughter, 8th race yesterday, and was forced to ease the horse through the stretch. The Official Veterinarian's office was notified and the horse was not placed on the vet's list. Trainer Harold Ladouceur was notified as well.

Race 1, slight delay to post parade for race 1, #3 Midray had thrown a fore shoe in the walking ring and was sent back into the paddock to be reshod. Race was off at 1:04. Race clear.

Race 2, #9 Tornado Cat threw head at start. Prevailed.
