Backstretch

- Jockeys Danielle DiBert and Dean Stimpson off their mounts today.
- CPMA Agent Ms. Millsap was here today.
- Owner Dan Giles (#8 Bewitchin, Race 5) shows as not being licensed. Mr. Giles did speak to the Stewards and presented his license. He says it was done at the start of the meet; however, it is not in the system. The horse was allowed to race and Stewards will follow up with the Licensing department.
- Rodney Quinn and Jennifer Gunn were in regarding an ownership disagreement of the horse Down Home Something with Brian Shewfelt. There is a contract signed for the year, but nothing that states what happens with the horse after Nov 1/18. The Stewards contacted Mr. Shewfelt and will be following up with both parties over the next week.
- #7 Rare Forms of Magic in Race 4 – Stewards Scratch (no rider available).

Races

- Timer and radio checks done.

Race 1 – Stewards Inquiry – reviewed racing at the start between #2 Dreams Arising (Norman Lloyd DeSouza), #3 Dinahlicious (Ramiro Sanchez Castillo) and #4 Sign It Down (Brian Bell). #3 is a step slow from the gate and breaks out to #4, which puts her in tight quarters. No video evidence of interference from #4. No violations or change to the order of finish.

- Timer malfunction for Race 1, utilized hand times. Timer check was done prior to Race 2, OK.

- Call from Dr. Oscar Calvet following the race stating #5 Memories Times Six bled. This is the 2nd time this horse has bled within 365 days while on the Lasix program. As per AGCO Rule 36.05.05, the horse Memories Times Six is suspended from racing in Ontario for 90 days, June 10 to September 7, inclusive. TB 10778.

Race 2 – JCOF – #2 Streakin Jet Speed (Normal Lloyd DeSouza) on #4 Kazoomin (Cory Spataro). Mr. DeSouza claimed that #4 cut him off and had to check his horse. Mr. Spataro stated that he was being bumped by #5 and that pushed him over. The video shows that #4 does come down and take away the path of #2 and that #5 did not cause interference to #4. #4 finished 3rd and was placed 4th for interference. A NOR was sent for Spataro.

- #3 Abbeys Cash (Ramiro Sanchez Castillo) stumbled at the start.

Race 3 – JCOF – #6 Code Name Valor (Nakia Ramirez) on #7 Jess A Sweet Suprize (Chelsey Willick) & TCOF #5 Up Your Bet (Cory Spataro) on #6 at the break. Ms. Ramirez said #7 ran over into her path and ducked right in front of her. Ms. Willick stated the horse got in on her on the 1st jump. Mr. Spataro said he could feel pressure from both sides. Upon video review, #7 does break in and into the path of #6. The video does not support that #7 caused any interference to #5, as that horse did break slow. As a result, the JCOF was upheld and the TCOF was disallowed. #7 finished 2nd and was placed 5th for causing interference to #6. A NOR was sent for Willick.
