Report on day's Events: (Backstretch - accidents, fines, suspensions, objections, disqualifications, refunds, pertinent incidents, general details etc., Film Reviews, Races, Claims)

Backstretch:

Starter Ian Ross attended to review the 5th race from June 8, 2018 in which the stall doors did not open when he dispatched the field. There appeared to be an error in maintenance and not the starting gate itself.

Spoke with owner Judith Adams regarding the horse Man Crush. The previous owner has held foal papers pending the assurance of a Veterinarian to assess the horse for health and welfare. A Veterinarian will be available on Tuesday to observe the horse and report back to the Stewards.

Trainer Shelley Fitzgerald attended our office to discuss a change of performance regarding Tornado Cat which placed first in the 2nd race June 9, 2018. She explained that the horses' prior performance in its last two races here at Woodbine were not bad and did not warrant a large win payoff yesterday. The horse has come around as of late in training and the 10 pound apprentice allowance is an advantage. The Stewards agreed with the explanation and no further action required.

Call to Trainer Sandra Dominquez, entered the horse Take Another Shot into the fourth race

today, she failed to have the foal certificate deposited into the Race Office, available for identification purposes, at the required time necessitating a Steward scratch. Notice of review issued. Will be in on Wednesday June 13, 2018, to address the issue.

Upon review of the tenth race from June 9, 2018. A Notice of review was issued to Jockey Chantal Sutherland for an alleged excessive urging infraction during the stretch run.

Film Reviews:

Race 3, June 9, 2018. Eurico DaSilva. Robert King as representative. Mr. DaSilva contends that the horse had a very light mouth and the horse was exhausted after setting very quick early fractions. He felt that if he urged during the stretch the horses' response would have a negative impact. We explained that the optics of this race were not favourable to the wagering public. He agreed and we accepted his explanation and no penalty was issued.
