- Chelsey Willick – Race 3 on June 10 – Ms. Willick's horse broke inward at the break and she quickly corrected the horse. This was a 2yo filly making her 1st lifetime start. No action taken against Ms. Willick.

Race 1 – Reviewed racing between #2 Home To Vegas (Ramiro Sanchez Castillo) and #4 Faster Than U (Regan Knowles) – #2 is clear of #4, no violations.

- Reviewed the use of the crop by Mr. Castillo – he is flagging with the crop and did not strike his horse more than 3 times in succession.
