Report on day's Events: (Backstretch - accidents, fines, suspensions, objections, disqualifications, refunds, pertinent incidents, general details etc., Film Reviews, Races, Claims)

Backstretch:

- 09:30 Trainer Steve Owens attended at our request and was issued a copy of investigative report for his perusal prior to our review with him next Friday.
- 10:10 Trainer Renee Kierans attended to complain that when waiting for the Official Veterinarian to arrive, Vet Tech Krista Tipping was in conversation with Trainer Jim Ensom at the end of her shedrow. From this vantage point Mr. Ensom was able to watch her walk her horse "Holtz" who is in todays' fifth race. Feels it is wrong and he shouldn't be standing at the end of her shedrow scoping out her horse.
- 10:35 Jim Ensom attended at our request to discuss the complaint from Ms. Kierans. Jim said it was raining hard and just stepped under the end of the barn and the vet tech happened to be standing there so I spoke with her. I had no intention of looking at her horse.
- 10:45 Trainer Anthony Pottinger attended re: Exercise person Alison Wood who was free lancing for Anthony and claimed she was injured on one of his horses. Anthony relayed he was unaware of the injury as she never reported it to him. Said she told him several weeks following the alleged incident asking that she need some physio therapy and is out of pocket for the visits. Said he never received any information regarding any incident. Advised he needs to speak with her and come to resolve.

11:00 – Exercise person Alison Wood attended and we explained to her our conversation with Mr. Pottinger. Alison explained that May 18, she was on one of his horses and when her right knee gave out and she came off. Next morning I couldn't walk and went to the clinic but they were unaware it happened while on the job, a week later I advised them and they sent the appropriate paperwork. Mr. Pottinger only needs to contact WSIB on my behalf with a form 7 from the employer. Re-connected with Anthony and advised he needs to furnish WSIB the needed document regarding her injury and needs to be done asap and he agreed.

Film Reviews:

Yesterdays' fourth race – two disqualifications.

Away from the gate, Sunny Singh, Sheena Ryan and Diasuke Fukumoto. Sheena said she got squeezed then clipped heels with Sunny's horse. Sunny said he heard her yelling first jump away from there and I wasn't close to her until a few strides later. Her horse caught the back end of mine which turned me into her and I know she clipped my heels so you did right in disqualifying my horse, not so sure I deserve days though. Daisuke said his horse was shying from the whip of the #2 horse to his inside, just tried to keep my horse straight. No action taken

Going into the far turn, Steven Bahen and Kazushi Kimura. Steve said he was well up in there and felt Kazushi could have given more room even prior to the incident down the backstretch. I got out of there because I could see it coming. He just didn't leave me room enough going into the turn. Kazushi said he was keeping a safety zone, the corner was there and knew Steven was inside but got pressure from the outside. In review, there did not appear to be any pressure placed upon Kazushi and Steve had established his position when his room was taken away. Three day suspension ordered for Kazushi.

Race 2 – Stewards Inquiry and Rider Claim of Foul (COF) by Ismael Mosqueira aboard #3 "Bear Paw" against #4 "H.M.S. Pinafore" ridden by Omar Moreno for interference through the stretch. Ismael said his horse was running good when the outside horse came down on him and stopped his momentum, finished second so thought I should claim foul. Omar said he moved in but never bothered anyone, never interfered. In review Omar does come down but stops short of contact and does not close the hole. At the same time the inside horse #5 "Desert Poem" with Patrick Husbands aboard is drifting out and it appears Ismael expected the hole to close but it never does. COF is disallowed.
