Turf races remain on Turf for time being and the Main Track Only (MTO) #7 Sweet City Woman, from the 1st race was declared out. Will monitor weather for remainder of Turf races.

Race 1 Turf, clear. Decision to declare out the MTO horses for the 3rd race, Turf.

Race 2, #4 Quilting Circle off a step slow, rest clear. Verbal caution, urging, Wilbert Gobay, raising hand above head level when urging.

Race 3, Turf, Stewards' Inquiry stretch run #2, Skippy is Back, 1st, S. Singh and #3 Bangla Dancer, K. Johnson, 2nd. Jockey claim of foul, #3 on #2 through the stretch. Upon review, upper pan and front tower angles, #2 does go out to #3 deep stretch and appear to make contact. The Stewards decided that #2 does interfere with #3 through the stretch by moving him out and making contact and #2 was disqualified from first and placed second. NOR for both riders on Tuesday.
