Report on day's Events: (Backstretch - accidents, fines, suspensions, objections, disqualifications, refunds, pertinent incidents, general details etc., Film Reviews, Races, Claims)

Backstretch:

10:45 - Received a Certificate of Positive, tag #73 18167 345, for the Class II drug Caffeine and its metabolites Theobromine and Theophylline from the horse "Gasconade" which won the seventh race on June 16, 2018 at Woodbine. The horse is owned by Bushlot Farm Inc. and Trained by Danny Yu. The horse was slated to run in today's seventh race and Mr. Yu opted to scratch out.

11:30 - Review for Trainer Steve Owens whose vehicle was inspected entering the grounds of the Woodbine Entertainment Group backstretch June 6, 2018 and subsequently revealed a syringe and bottle of Dormosendan.

12:30 - Due to the heat and humidity this weekend several cautionary measures have been implemented by the Woodbine Entertainment Group. Official Veterinarian Dr. Bondar has generated a fact sheet for Trainers that has been forwarded to all outlining the precautions to be taken prior to race day, race day and how to deal with heat stroke. There are two extra vets on duty for Queens Plate day bringing the total to four. Shaded areas provided for There are several cooling stations set up for horses immediately following the race and prior to unsaddling as well as many hoses, ice buckets and sweat scrapers available for the return to the stabling area. Rubbing alcohol and sponges will be available to start the evaporative process and assist the animal to release heat buildup. Post parades will also be lessened.

Film Reviews:

Race 6 from Sunday June 24, involving riders Emile Ramsammy and Ademar Santos for interference during the stretch run. Emile said his horse was full of run and we were approaching the wire when Ademar's horse came over into him knocking him off stride. Only beat me a short margin, believe I still had a chance at the win until then. His horse was lugging in with him. Ademar said his horse was lugging in hard and did his best to keep off of Emile. Felt Emile's horse stepped out a bit at the same time making it seem worse. No action taken.

Races:

Race 1 - #4 "Forester's Destiny" with Kazushi Kimura aboard was off slow.

Race 2 - #6 "Mr Ritz" ridden by Eurico Da Silva drifted out through the stretch.

Race 3 – Clear

Race 4 - # 2 "Puzzling Kitten" ridden by Rafael Hernandez pulled up on the far turn.

Race 5 – As the horses turned for home on the turf our upper pan video was blocked out from the 5/16 pole to just inside the 1/4 pole. Spoke with the TV department who were aware of the issue, apparently a TV production camera was being set up for tomorrows Queens Plate. Problem to be resolved prior to next turf race. Observed Jockey Eurico Da Silva strike his mount "Marsantropist" more than three times in succession during the stretch run.

Race 6 – The Lady Angela Stakes - #6 "Gosudarina" required to have a shoe tacked on in the paddock. #3 "Bear Kitty" with Alan Garcia was off slow.

Race 7 – Reviewed the stretch run regarding #2 "Decidionsdecisions" ridden by Luis, #4 "Bakersfield" ridden by Rafael Hernandez and #5 "Spanish Express" ridden by Slade Callaghan. Rafael puts the squeeze on Luis on the fence top of stretch but Luis gets through and finishes ahead of Rafael. Slade Callaghan outside both of them at the time does not pressure Rafael or Luis. Second incident to the outside turning for home involving #3 "Get My Gist" ridden by Ademar Santos and #7 "Courtly Manner" ridden by Eurico Da Silva. Ademar swings wide off the turn and into the path of Eurico, however, Eurico finishes ahead of Ademar at the wire. There were no Inquiries as those impeded finished in front of the offenders and their actions did deserve a call to movies.

Race 8 - #5 "Afleet Doll" ridden by David Moran made a left leaving there and into #4 "Junebug Jitters" ridden by Skye Chernetz causing that one a rough start, finished twelfth and thirteenth, no inquiry. Warned Jockey Jorge Expitia about standing up at the wire.
