**Report on day's Events:** (Backstretch - accidents, fines, suspensions, objections, disqualifications, refunds, pertinent incidents, general details etc., Film Reviews, Races, Claims)

### Backstretch:

Due to the heat and humidity today several cautionary measures have been implemented by the Woodbine Entertainment Group. Official Veterinarian Dr. Bondar has generated a fact sheet for Trainers that has been forwarded to all, outlining the precautions to be taken prior to race day, on race day and how to deal with heat stroke. There are three extra vets on duty today bringing the total to five. Shaded areas provided for saddling and several cooling stations are set up for horses immediately following the race and prior to unsaddling as well as many hoses, ice buckets and sweat scrapers available for the return to the stabling area. Rubbing alcohol and sponges will be available in the winners' circle and unsaddling area for those who wish to start the evaporative process and assist the animal to release heat buildup. Post parades will also be lessened.

09:15 – Trainer Steve Owens advised of penalty following yesterday's review of medication violation. Monetary penalty of \$1,000.00

10:05 – Jacques Beaudouin attended at are request to speak to the herbal product he is selling on the backstretch. Advised the products are not properly labelled and he needs to stop providing the product immediately and until such time as he submits to us a list of ingredients and labelling that is satisfactory to our Official Veterinarians. He explained that the products are herbal and do contain preservatives but is concerned that the more they describe the contents it gets into copyright issues which are costly. We advised it needs to be done correctly and until such time he is to stop selling the products.

Review with Eurico Da Silva for using his crop in and excessive manner on "Courtly Manner" in the seventh race yesterday. Eurico said he realized the moment he went four but his last offence was September of 2017 and always does his best to follow the rules.
