Report on day's Events: (Backstretch - accidents, fines, suspensions, objections, disqualifications, refunds, pertinent incidents, general details etc., Film Reviews, Races, Claims)

Backstretch:

Due to the heat and humidity today several cautionary measures have been implemented by the Woodbine Entertainment Group. Official Veterinarian Dr. Bondar has generated a fact sheet for Trainers that has been forwarded to all, outlining the precautions to be taken prior to race day, on race day and how to deal with heat stroke. There are three extra vets on duty today bringing the total to five. Shaded areas provided for saddling and several cooling stations are set up for horses immediately following the race and prior to unsaddling as well as many hoses, ice buckets and sweat scrapers available for the return to the stabling area. Rubbing alcohol and sponges will be available in the winners' circle and unsaddling area for those who wish to start the evaporative process and assist the animal to release heat buildup. Post parades will also be lessened.

09:05 – Trainer Dale Desruisseaux attended to see the video of yesterdays' eleventh race and his horse #9 "Lapochka". I was unable to pull up the video, however, I relayed to Dale we are planning to have a video review later this morning in the Jockey's Quarters. We did speak to his rider following the race which is denoted on yesterdays' report and the fact we had technical issues in uploading the corresponding video. We are optimistic it will be resolved later today.

09:15 – Trainer William Armata called to say his owner wants to change the rider they named for this coming Wednesday July 4. Advised unless the rider agrees to the removal, we will not take him off the horse.

10:20 – Trainer James Smith attended to complain he has a problem with electricity in his barn and is unable to use the fans for his horses. It was checked and apparently the breakers are working but not any of the outlets. Would like us to follow through with Woodbine in an attempt. After James left he called back to say WEG sent over an electrician and is currently working on the problem.

11:20 Owner Isaac Goorwah of Bushlot Farm attended per our request and was advised that his horse "Gasconade" has been placed on the Stewards List and ineligible to enter or race in Ontario until further notice. "Gasconade" provided a positive result for Caffeine and its metabolites following the seventh race on June 16, 2018.

Film Reviews:

Review of yesterdays' eleventh race involving Jockey Alan Garcia and his ride on #9 "Lapochka" Rob King accompanied Alan to the Stewards Stand after the second race for the review. Alan explained that the horse Jesse Campbell was on to my out sided looked as though he was going to keep coming in, I anticipated he was going to close the hole and made my decision to opt out and go to his outside when I realized too late he had stopped his inward path. It was too late to change back at that time.

Race 1 – Report from Paddock Judge Harold Fortune that #3 "Moon Swings" trained by Michael P. De Paulo did not arrive into the paddock until fourteen minutes to post.

Stewards Inquiry regarding an incident at the ¼ pole involving #2 "Hesathriller" ridden by Gary Boulanger, #3 "Moon Swings" ridden by Eurico Da Silva and #6 "Bitethebulletbro" ridden by Chantal Sutherland. Gary said he wasn't sure if Eurico was having pressure outside or his horse was lugging in but I end up bouncing off the fence. Eurico said his horse shied from Chantals' to his outside but felt Gary may have stepped out as well. Chantal said her horse was getting in with her but did her best to provide room for the horses inside. After review it was difficult to pin the fault directly on Eurico as it does appear from the back tower shot that Gary's horse may have stepped out at the same time Eurico was approaching Chantal. No Change
