**Report on day's Events:** (Backstretch - accidents, fines, suspensions, objections, disqualifications, refunds, pertinent incidents, general details etc., Film Reviews, Races, Claims)

## Backstretch:

Wm. Therranos was in about the ownership of a horse in the last race which was in the ownership of Six Brothers Stable only. At our request he provided a bill of sale from the Sale at which this horse was purchased. The papers had an additional partner who was bought out at the sale in November of 2015.

Trainer Sharon Ceccato gave a rider change in Race 2 to the Race Office from A. Santos to H. Vanek. Mr. Santo spoke to us later to say that he had the call. The switch was denied.

Also discussed with Management the need to have the golf cart with buckets of water closer to the exit gap from the turf course so cold water can be applied if the need arises. This is an area where hoses are not reachable.

## Film Reviews:

Review of R3 on July 01 with Juan Crawford. His mount was driving coming from off the rail and stepped out while under left handed urging. The horses outside of him were very tired and wobbly and his actions had no real effect on them as to where they finished. However the Stewards wished to bring to Mr. Crawford's attention his habit of hitting left hand from the point of the turn and at the head of the stretch which can be contributing to mounts running out .No action taken **Races:**

R5-Reviewed the run down the backstretch at the request of #3 Pinto (5<sup>th</sup>) who felt that the #4 D. Johnson (6<sup>th</sup>) was not steering his horse and who she felt made it tight causing her to be on heels. Spoke to #4 Johnson who said the horse was running in badly right from the beginning. R6-Clear/ Dead heat for 4th

R7-Stewards Inquiry and JCOF #1 Carignan (5<sup>th</sup>) AND #3 Chernetz (2<sup>nd</sup>) on the winner #9 Alderson in the last turn. Carignan indicated that she got squeezed bad by #3 and she wasn't sure if the pressure came from the #9. Chernetz said she was in trouble with a green horse and was yelling for #9 to release the pressure on her. She felt the #9 was at fault. #9 Alderson said that he was outside the two and was tracking the horse on top which he was outside of. After reviewing the films the Stewards ruled that the #9 horse not at fault and that the #3 horse was running green and erratic coming in and causing interference to #1. #3 finished second and placed for interference.
