Alan Garcia said his horse was running green with him but didn't feel he caused the incident. Rafael explained that while he agreed with the decision to disqualify his mount, he did not cause the interference intentionally. Said when he decided to pull out behind the two leaders and Alan's horse made a step out at the same time, his two year filly shied and went out further than expected. I only beat him a neck. After discussion we chose not to take any action against Rafael.
