### Report on day's events:

#### Office

- Manager of Racing Tom Miller was present this afternoon.
- Review with Erik Lehtinen regarding an incident at Ajax Downs on May 27/18. Decision reserved.
- The Panel held a film review with Ramiro Sanchez Castillo concerning the use of his crop during Race 4 on July 8. The film was inconclusive and no further action is required.
- Decision from Review with Greg Watson on July 8. Mr. Watson was found to be in violation of AGCO Rule 16.05(c) – *show disrespect by word or action to any official of racing* – and was assessed a \$1,000 monetary penalty and 30 day full suspension, August 1/18 to August 30/18. Mr. Watson also had Probation terms added to his license for a period of one year, August 31/18 to August 30/19. AGCO Rules 16.02.01, 16.13(c)(d)(g) and 24.04 apply. QH 10846/18.

#### Races

- Radio and Timer check, OK.

Race 1 – #7 Ocean Dinastia (Tyler Slater) broke slow from the gate. Race All Clear.

Race 2 – TCOF – #6 Rouge River Cartel (Chelsey Willick) on #7 Swingin Bear (Cesar Esqueda) and JCOF – #5 The Dominyunator (Cassandra Jeschke) on #4 Charted by DM (Neil Husbands). The video shows that #7 does not come down and remains in his path. #4 is going out, but is clear of the outside horses. #5 and #6 appear to come together and that causes Willick to check her horse and go behind #7. The Panel ruled that #7 did not cause any interference to the inside horses and #4 did not cause any interference to the outside horses. Both COFs were disallowed and no change was made to the order of finish.

Race 3 – Inquiry – Reviewed racing between #1 Draggin Wagon (Cory Spataro), #2 Chester Nez (Cassandra Jeschke), #3 A Streak of Flo (Neil Husbands), and #4 Ocean Front Jess (Corrine Andros) after the start. The video shows #4 comes down and pushes #2 onto the heels of #1. #4 finished 7<sup>th</sup> and was placed 9<sup>th</sup> for causing interference.

Race 4 – JCOF X 3 - #1 I Think Icon (Chelsey Willick) on #2 Flirt With the Boyz (Tony Phillips), #2 on #4 Chase This Yawl (Brian Bell) and #4 on #6 Smoakn Gun (Cory Spataro). The video shows that #6 bolts in on Spataro and causes interference to the inside horses. #6 finished 1<sup>st</sup> and was placed 7<sup>th</sup> for causing interference to #s 1, 2 and 4.

Inquiry – #8 Panther Cool (Cesar Esqueda) stumbled out of the gate and unseated the rider. The horse was ruled to have received a fair start.

Race 6 – #5 Highly Apollogetic (Rene Gutierrez) stumbled at the start. #10 Code Name Valor (Brian Bell) broke outward. Race All Clear.

Race 7 – Inquiry – Reviewed #7 Junoimzoomin (Chelsey Willick) at the start. The video shows that #7 was held at the break and received an unfair start. As per AGCO Rules 16.12 (b) and 16.12.01, #7 was refunded for pari-mutual purposes and will receive 4<sup>th</sup> place money. Refund \$1,513.
