Backstretch:

09:50 – Exercise riders Renico LaFond and Oral Anthony attended to speak to galloping on the fence yesterday impeding workers at the ³/₄ pole. Both said they realized they were wrong and apologized to the riders as they pulled up. Said they understand it is a safety issue and will make sure it doesn't happen again. Monetary penalty of \$100.00 each.

10:20 – Director of Thoroughbred Racing Steve Lym attended to discuss race office entry procedures. Steve relayed that in an effort to create the best possible fields, they are not necessarily able to close the box at a designated time. The Woodbine rule of an 11:30 closing time is no longer practical and needs to be adjusted or eliminated. The current shortage of horses dictates a need to extend the time in order to hustle entries and fill races and this is common practice in North America. Occasionally we are made aware of missed entries and will take the time to investigate the information and if correct, contact the trainer. This is done as a courtesy to the horse people and the benefit of racing in general. We advised that any changes in policy continue to be brought to our attention for approval.
