- Following Race 3, the Jockeys requested a vote to determine whether the track was safe to continue racing. Following a discussion between the Jockeys, Track Management and Maintenance, a horseman's rep, and the Race Officials, it was agreed upon that the races would be delayed for 30 minutes to give Track Maintenance time to work on the track. The parties would reconvene at 2:45 and a determination would be made at this time to continue or cancel racing. At approximately 3:00, a Jockeys vote was held and as per AGCO Rule 3.15, *'if the vote of the jockeys determines that more than 50% vote against racing, the card will be canceled.'* The vote determined that racing would continue and any jockeys that wished to not ride were given permission to cancel their mount.

- Jockeys Brian Bell and Cassandra Jeschke excused from the remainder of their mounts.
