Race had three entries at 12:53 but was not closed when she entered into a race at Woodbine for Wednesday July 25, 2018. It did not fill at fort Erie and eventually called off. We explained she needs to appear before the Stewards at Fort Erie on Tuesday July 24, 2018. She said she will appear.

Race 1, Mdn 2 yr. olds. #1 dangerous Star and #2 Hastalavistababy were both off a step slow.

Race 2, Off Turf, Stewards Inquiry #1, Secretsof the Nile, J. Lermyte, 1st and #2 Avie's Zip, L. Contreras, 4th, at the start. Jockey claim of foul #2 on #1 at the start.

Upon review of the upper pan and the back tower angles, #2 bares out at start to #4 and is a little slow. #1 fills the void and moves out from the rail but appears to be clear. #2 has to check but not of any fault of #1. The Stewards after review of the film and speaking with the riders involved, decided the #2's start was compromised prior to the #1 moving out to his path and disallowed the claim of foul.
