Backstretch:

12:45 – Owner Jim Ogilvie attended to complain that his horse "Our Victor" was scratched at the gate Sunday's seventh race and feels it was the rider that didn't want to ride and convinced the vet to scratch the horse. Trainer Tom Steer was present and feels he sent a sound horse out to compete. We have explained that if a rider is uncomfortable on a horse and take it to the vet the horse will be scratched. This is policy, if the vet were to send for another rider then something happened the liability could fall on them. We spoke with the Official Vet who said Melanie brought the horse over for inspection and said she didn't feel the horse was going very good, it was at that point it was decided the horse should be scratched. Spoke with Melanie Pinto who said the horse was fine jogging but when she got it into a gallop it didn't feel good at all.

14:10 – Trainer Shana Lopez attended re: entered into two overnight races. She said she did put the horse in here at Fort Erie but was told the race wasn't going to fill. At that point I wanted to get the horse in so I called Woodbine and entered there. I wasn't trying to take advantage of the situation, it was just a matter of being able to run somewhere. The race I entered into at Fort Erie never filled. Due to the fact the race was never used and there was no need to scratch her horse, no action was taken against Shana.
