Upon review of the upper pan and front tower camera angles. #3 is battling with the #4 as they make contact a couple of times and the #1 is coming in slightly from the outside. #3 does check but the #1 is clear by that time. Santos felt he was clear and Moran stated he wasn't able to claim foul with the man stationed at the ¾ pole because his horse didn't gallop out that far, but felt he was interfered with by the #1. The claim of foul was disallowed and the order of finish remained.
