Races on the turf today will be run at an about distance.

Race 1, clear

Race 2, #2 off a step slow, rest good.

Race 3, Turf, #6 bore out at the start, rest good. Turf downgraded to good

Race 4, #1 Fiery bear off a step slow, #5 JMR Silent Sam and #6 fine Grind were outdistanced, rest ok. Turf downgraded to yielding.

Race 5, #1 Queen of the North off a step slow, rest good

Race 6, Catch a Glimpse Stakes, clear

Race 7, Stewards' Inquiry, #7 Majestic Slew, J. Campbell, 1st, #6 Speightstown Time, C. Husbands, 3rd and #3 Valiant Flame, K. Kimura, 4th, top of stretch. Upon review of the upper pan and front tower camera angles, it appears the #7 does take a step out from the inside and the #3 is on the outside and #6 is in the middle but not quite there. #6 C. Husbands felt that #3 forced him in and the #7 inside wasn't a factor, #7 J. Campbell didn't feel his mount interfered with anyone else. #3 K. Kimura wasn't aware there was an issue. Not enough sufficient evidence to support a placing. No change to the order.

Race 8, Turf, Play The King Stakes, clear, verbal caution to #1 Florent Geroux, 5th, raising hand above head level while urging through stretch.

Race 9, Stewards' Inquiry, Jockey claim of foul, #2, Thunder Ride, P. Husbands, 4th on #1 Salieri, Garcia, 1st. Upon review of the upper pan and front tower camera angles it appears #1 does go out, under left handed urging and interfere with #2 approaching the finish.

#1 Alan Garcia felt he didn't go out that much, didn't bother him, he over re-acted

#2 P. Husbands, had to take a hold to avoid his heels.

It was decided that #1 did go out and interfere with #2 approaching the finish and was subsequently disqualified from 1st position and placed 4th.
