Report on day's Events: (Backstretch - accidents, fines, suspensions, objections, disqualifications, refunds, pertinent incidents, general details etc., Film Reviews, Races, Claims)

Backstretch:

Film Reviews:

Review of Sundays second race involving Jockey Jerome Lermyte for misuse of the crop. Following the race we had received a report and two photos from the Official Veterinarian of a welt and cut on the right flank fold of Jerome's mount #2 "Differential". The Veterinarian examined the horse at the test barn and verified the infraction. Mr. Lermyte was shown the two photos but was of the opinion that he could not have caused that and it could have occurred in the starting gate. We reviewed the stretch run and showed him where he was not reaching back with his crop. He had his own photos and verified there was blood and welts but again refused to believe he was the cause. This infraction demands a monetary penalty of \$300.00 and a one day racing suspension to be determined later.

Review of the sixth race involving Jockey Christopher Husbands leaving the starting gate. Chris said his horse broke immediately to the inside and straightened as quickly as I could, nothing more I could have done. It was evident it was the first couple jumps out of there, no action taken.

Race 4 – Stewards Inquiry and Rider Claim of Foul by Juan Crawford aboard #4 "Apollo Benfica" against Daisuke Fukumoto aboard #3 "Shelbourne" and Rafael Hernandez aboard #6 "Hidden Artifact" for interference going into the far turn. Juan said #3 came out and took my space and #6 on the outside wasn't giving me any ground, was in a real bad spot. Rafael said the inside came out and hit his horse's hind end pretty hard, my horse gave up after that. Diasuke said he knew Juan was outside him so he tried to make his move carefully. After review we disqualified Diasuke's mount #3 from second and placed him sixth behind #4. A second Stewards Inquiry into further interference by Juan Crawford onto Kirk Johnson aboard #1 "Distorted Rhythm". Juan said I was just trying to take care of my horse after the first incident, wasn't trying to ride him out after that. Kirk said I was on the fence and Juan came right on top of me, my horse almost jumped the fence, had nowhere else to go. After review we disqualified Juan's mount #4 from fifth to seventh behind #1.
