Races

Race 1 – Inquiry/Accident in the stretch – #4 Dont Write Me Out (Matt Harvey) attempts to pass #2 Pickem (Ryan Guy) on the inside and hooks #2 from behind, which caused Guy to be unseated from the bike. #4 finished 5th and was disqualified. #2 was charted with an interference break.

- Guy was checked by EMS and reported OK. #2 ran loose in the stretch and was caught in the winners circle. Both horses were reported OK.

- Matt Harvey – AGCO Rule 22.05.01(h) – 5 day driving suspension, May 28 – June 1, inclusive. SB 50763

- Reviewed the break by #1 Iamsam Samiam (Doug Hie) in the stretch, finished 4th – no violations of the breaking rule.

- #7 Pick Up Man was an early scratch and was given to Tote by the Placing Judge at 6:00pm and 6:30pm when changes were communicated. Although scratched on

the TV, #7 was still showing in the pools on the in-house odds channel. The TV displays then froze at 5 MTP. There was a slight delay to confirm with WEG that #7 was scratched from the pools. Following the race being made official, the Tote system failed and needed a complete reboot. Once the Tote system was back operating, there was a technical issue with the TV displaying the odds on the graphics. The Judges ensured that TVs in the grandstand displayed the in-house odds channel so patrons could see live odds. The TV graphics could not display post times but they were announced to the public throughout the night. There was a delay of approximately 50 minutes for Race 2.
