They relayed they were on young horses and it was late in the morning, rider came up on us quick and we didn't hear him. We advised it's a wide race track and training rules state it is strictly forbidden to gallop on the fence, can create a dangerous situation. Monetary penalty to each, \$100.00

Race 5 – Stewards Inquiry into an incident at the top of the stretch involving #7 "Roman Nomen" ridden by David Moran and #9 "Shelbourne" ridden by Leo Salles. David said everything was fine until the inside horse #9 came out and bounced me around, completely took my ground. Said he would have claimed foul but he pulled up short and didn't reach the outrider to tell him. Leo Salles said he moved his way out for the hole and it was the outside horses that created the problem. After review we disqualified #9 from fourth and placed him tenth behind #7. Notice of review sent to the Jockeys quarters. Trainer Robert Gerl called to question the decision to disqualify his horse, we explained our position and invited him to view the video again with us tomorrow.
