### Film Reviews:

Jesse Campbell for excessive use of the crop. Jesse said he didn't realize that both, he had hit his horse so many times or that he was also five in front when continuing to do so. We have given Mr. Campbell fair warning prior to todays' review and he needs to curb his use of the crop much more. Jesse was issued a one day suspension and an monetary penalty of \$300

Leo Salles, disqualification of his mount in yesterdays' fifth race for interfering with David Moran at the top of the stretch. Leo said he was just looking for room and doing the best he could to win. Didn't realize the extent of the violation until he looked at the replay following the race. David said he was bumped several times hard until his room was completely taken, was in a bad spot. Mr. Salles was issued a three day suspension, days to be determined.

Race 1 - #1 Caseyoudid'know" ridden by Ismael Mosqueira was away slow

Race 2 – Stewards Inquiry into an incident shortly after leaving the gate involving #3 "Jenny's Victory" ridden by Kazushi Kumura, #4 "Diva On a Dime" with Leo Salles and #6 "Gypsy Jazz" ridden by Daisuke Fukumoto. Daisuke said his horse broke quickly and he looked to his left when dropping over and thought he was clear. Leo explained he was stuck between the two apprentices and saw Daisuke coming over, could see a problem arising and tried to ease out before Diasuke got to him, had to steady. Kazushi said his horse broke fast and had to check hard when Daisuke came over onto him, caught his heels. After review, we disqualified Diasukes' mount #6 from second and placed him fifth behind Kazushi's mount #3.
