R3-Stewards Inquiry (X2) and Jockey Claim of Foul #2 Knowles (6<sup>th</sup>) on #1 Andros (1<sup>st</sup>) and #3 Castillo (2<sup>nd</sup>) on #1 in the stretch. Stewards Inquiry also on the #5 and #6 at the break

Stewards Inquiry just before the wire between the #1 Andros (1<sup>st</sup>) and the #4 Jesche (3<sup>rd</sup>) After reviewing films and speaking to the riders affected:

Steward's inquiry between #5 and #6 no change. The #6 broke in the air and inward, #5 broke slow.

Jockey Claim of foul #2 on #1 disallowed. #2 broke slow #1 came across but was clear.

JCOF #3 on #1 early stretch. #1 bears out and cuts #3 off forcing him to the inside Upheld

Steward's Inquiry. # 1 repeatedly bears into and bumps #4 before the wire knocking it off stride. Rider of #4 did not claim foul as she felt it was obvious.

#1 Teller a Secret finished 1<sup>st</sup> and placed 3<sup>rd</sup> for causing interference to #3 and #4 in the stretch run

Gate was switched as the riders felt there was an issue with the #5 gate. Nothing that the Stewards could see as a problem of the gate but rather of the horses but management switched gates.

Call from the test barn that the winner #3 Shes Sizzling (2<sup>nd</sup> placed 1<sup>st</sup>) went to the test barn had blood taken for Lasix thought it was finished and left barn returning 5 minutes later. Stewards ordered test to take a urine sample. Trainer Erik Lehtinen to attend our office next week
