Report on day's Events: (Backstretch - accidents, fines, suspensions, objections, disqualifications, refunds, pertinent incidents, general details etc., Film Reviews, Races, Claims)

Office:

Trainer Blair Miller attended questioning a claim submitted by Sharon Ceccato on June 12, 2019 for the horse Blue Collar Romance. Mr Miller questioned the eligibilty of the claim due to the qualifying horse that was used on the claim slip. After further review, the information submitted on the claim was correct.

Trainer Daryl Hasmatali questioned the late decision to remove todays' races from turf to tapeta due to yesterdays' rain. He asked how late would we allow for a scratch to be submitted for the first race. We informed him that we would be attending to scratches around 10:30 after the Veterinarians completed their race day examinations, and that he would need to have submitted prior to that time.

Trainer Peter Berringer attended to make his statement regarding a Security report submitted to the Stewards involving an alleged altercation of two exercise persons at the on gap to the main track on June 12, 2019. His statement helped clarify some details that were questionable.

Film Reviews:

Race 5, June 19, 2019. Simon Husbands, #4 Apprentice Nicole Alderson, #2 and Keveh Nicholls, #1. Rep Irwin Driedger attended. Incident occurred in the run down the backstretch.

Nicholls felt that the pressure was from the outside, had to check. Thought the #4 was pressured by the #6 outside of the #4

N. Alderson said she had to check it got tight, #4 was on her outside.

S. Husbands, going down backstretch, tapped her on the shoulder, leaned in, and overreacted. They shortened blinkers on her and she was a little shy, was all over the place.

Mr. Husbands issued a three day riding suspension, days to be determined.

Races:

At 12:00 PM, Woodbine conducted a mock race on the new inner turf course. Six horses contested a five eighths race. There appeared to be no issues from the Stewards' stand outside of the Turf front tower camera did not operate for the race itself but was operational after the fact.

Races 1, 3, 5 and 7 are off turf today and will be run on the Tapeta at their respective distances.
