- A Review was held with Trainer Lenore Dubois and Owners Sherry and Tony Camilleri of Malta Manors Stables regarding a possible violation of the Race Day Medication Ban on June 4/19 at Fort Erie Racetrack with the horse Big Black Storm in Race 2. An Investigation (File 19-258) was done by Compliance Official Amanda Farrell. There was no evidence that the horse Big Black Storm was administered any medication within 24 hours of the first race on June 4. As a result, Mrs. Dubois was not in violation of AGCO Rule 15.38. The purse money for the race has been released and no further action is required.
