- Ryan Holliday, Scott Wray and Jason Ryan excused from 1 drive this evening.

- Judges spoke to Bernard Lavigne regarding Race 4 at Clinton Raceway on June 30/19 when he was driving the horse Oforpetesake. Mr. Lavigne did urge the horse in an excessive manner and as a result was found to be in violation of his probation terms laid out in SB Admin Ruling 17/2019. Mr. Lavigne must serve the stayed portion of the penalty – \$1,500 monetary penalty and 10 day driving suspension (July 3-12/19). AGCO Rules 22.23.01(b), 22.23.03(b)(c), 22.23.05(a)(b)(e), Policy Directive No.5-2009. SB 49629. Mr. Lavigne is immediately suspended from driving as of July 13/19 and referred to the Director of Regulatory Compliance for his 4th urging violation within 1 year. SB 49631.

- Mike Hamlin – Ineligible to be licensed until purse money is returned from SB 50601. AGCO Rules 5.11, 9.13, 18.08.01, SB 51811.
