Mr. Moran explained that his horse, #4, was very tough to keep back early, the trainer instructed him to try and keep off the pace. The horse was rank and as he angled out to avoid #5's heels and under a hold, he bumped E. Wilson #6 and in turn her horse bumped #7, L. Contreras. #4 was 1st placed 4th.

In assessing penalty, the Stewards look to the error of Jockey or horse, in this case it was a little
