It was brought to our attention by the racing secretary Scott Lane that we may want to review the horses first two life time races before deciding to decline the change. We did review both races and the horse bolted at the top of the stretch in each case, once with open blinkers and the second time without blinkers. We determined the horse does require the full cup blinkers and due to safety we will allow the change for todays' race.

09:50 – Hot walker Ken Street attended to relay that he has a problem with another employee in the barn, doesn't know the person's name. We advised he attend security to report the incident and once we receive the report we will have everyone in to discuss the situation.

10:05 – Groom Anthony Cirillo attended with Trainer Angus Buntain to address Tony's actions towards an official vet tech on July 21, 2019 at Fort Erie. Tony said he was trying to protect the girl because the horse can be a handful and didn't want her to get hurt. Said he did use profanities but not towards her. Angus relayed that Anthony did get upset and loud but the horse is difficult. We advised there is a way to conduct oneself towards people and if the horse is difficult, getting loud and worked up will not help the situation. Monetary penalty \$100.00
