## Office:

9:30 – Jockey agent Jordan Miller attended to speak to the incident in yesterdays' last race involving his rider and Leo Salles. We spoke about both riders hitting each other inadvertently and there is a review slated later this morning to address that with each of them.

## Film Reviews:

Yesterdays' second race regarding Sahin Civaci and the use of his crop, Sahin said he has been trying hard to curb the use of his crop and realized after his mistake.

Race eight involving both Kazushi Kimura and Leo Salles. Both riders agreed they were close to each other and did get their sticks tangled in the finish to the wire, neither meant to make contact with the other.

## Races:

Race 1 – Clear

Race 2 – Received a call from the broadcast department prior to the race explaining we will not have a front tower. Apparently the camera man had disturbed a wasp nest and has been stung, not willing to go back in the tower at this time. Property services has been contacted and is to address the situation. Race clear

Race 3 – Clear

Race 4 - #1 "Awesome Flight" ridden by Justin Stein stumbled leaving there, bore out steadily thereafter. Eventually the saddle slipped, was pulled forward and the horse was eased through the stretch.

Race 5 – Clear

Race 6 - #4 "Addi Bear" ridden by Devon Johnson was away poorly.

Race 7 – The Victorian Queen Stakes – Clear

Race 8 – Stewards' Inquiry and Rider Claim of Foul (COF) by Juan Crawford aboard #9 "Auntie Katherine" against #4 "Zephan" ridden by Simon Husbands and #5 "Awesome Halo" ridden by Leo Salles. Juan said he is between horses and the #4 came in and #5 came out, got squeezed real bad, had no chance. Simon on #4 said he stayed straight, never went in at all. Leo on #5 said he was pushed out by #2 "Itstartswithadrink" ridden by Corey Jordan when that one pushed his way in along the fence. Corey said he saw the hole on the fence and went for it, never came out. After review, it was evident that Mr. Jordan did squeeze through and in the process forced Mr. Salles out and into the path of Juan Crawford. #2 was disqualified from second and placed eighth behind #9
