## Office:

Dealt with several incidents of misconduct on the backstretch this morning.

### Film Reviews:

Review of yesterdays' second race with Kazushi Kimura who ran up onto heels just past the wire first time around. This was an educational session with Kazushi to advise he needs to be aware of his positioning and of those around him at all times. Irwin Driedger was present and stressed our point to Kazushi who relayed he understands and will take our advice and learn from his actions.

Race 6 – Skye Chernetz for excessive strikes leaving the gate, seven in a row. Skye said she didn't think that hitting on the shoulder counted. Monetary penalty of \$200. Leo Salles for excessive strikes approaching the wire, seven in a row. Leo said he was trying to get the best out of his mount and finish the best he could. Monetary penalty of \$200.

## Races:

Race 1 – Stewards inquiry into the stretch run involving #5 "Our Zuma" ridden by Leo Salles and #8 "White Sage" ridden by Jeffrey Alderson. Jeffrey said they did come together but felt Leo may have come out to him. Leo said his horse was in and out with him but felt in late stretch that Jeffrey may have initiated the contact. After review, it appeared each did move in the directions as mentioned and both played an equal part in the contact, no change.

Race 7 – Jockey Claim of Foul (COF) by Leo Salles aboard #3 "Mamita's Chica" against Patrick Husbands aboard #6 "Hanchy" for hitting his horse with the crop at the head of the lane. Trainer Saul McHugh also claimed foul against #6 for interference to his horse #5 "Happycrest" ridden by Simon Husbands for interference through the stretch. Patrick said he kept straight and never went in or out. He was advised the COF was for him catching Leo's horse across the face with his crop, Patrick didn't respond further. Leo said Patrick caught his horse twice across the face and his horse stopped trying after that. Simon Husbands said he was never bothered at any point in the race. After review, we did see one strike to the head of #3 by Patricks' crop at the top of the stretch further evidenced by the reaction of the horse, we could not make out a second strike. Patricks' mount #6 was disqualified from third and placed last behind #3. The Trainer COF was disallowed.
