09:30 – Jockey Omar Moreno called in asking to be excused from his mounts today, allowed.

10:45 - Trainer Blair Miller attended re: entering into two overnight races without being scratched from the first. Said he entered in the Fort and said if the one race didn't go he may go in the second. Saw there was a race here at Woodbine so called Fort Erie and spoke to a woman, not sure who, said I was out. Entered into Woodbine then later saw the overnight for Fort Erie and saw the horse in the first race. We spoke with Fort Erie and they said no one spoke with Blair

10:50 – Jockey Agent Pramodh Seebah attended to pick up an appeal form for his rider Leo Salles in regards to the Wednesday October 2 disqualification of his mount and subsequent three day suspension levied for interfering with another horse by use of his crop.

Race 1- Clear, very close photo between #5 "Victor's Way" and #6 "Wiley O'Rielly" for second place. Determined #6 did nose out #5. Owner Ryan Kerbal called to question if it should have been considered a dead heat. We explained our position and invited Mr. Kerbal to attend the stand and review the photo on the monitor.

Race 7 – Observed the #3 "Money Talks" ridden by Christopher Husbands bobble half way around the clubhouse turn. Christopher said his horse took a bad step, no one was around me, just did it on his own. Looked at the spot pulling up and didn't notice anything wrong with the turf. Video is inconclusive.

Race 8 – The Mazarine Stakes – Stewards Inquiry into two separate incidents, one into the Club house turn and the second during the stretch run. Jockey Claim of foul (COF) by David Moran aboard #1 "Take Charge Eh" against #2 "Skygaze" ridden by Jerome Lermyte for interference into the Club house turn and a second Rider COF by Eurico Da Silva aboard #3 "Curlin's Voyage" against Jerome for interference through the stretch. Moran said he just came right over and put me into the rail, took my space. Jerome said he never bothered anyone in the first turn and said through the stretch he did go out but was out in front by himself, clear and nowhere near anybody. Eurico said he saw Jerome starting to drift and thought he was just going to come to but all of a sudden he came out hard in front of me and I was on his heels, had to check hard. After review, #2 "Skygaze" was disqualified from first and placed third behind both horses that were interfered with.
