**Report on day's Events:** (Backstretch - accidents, fines, suspensions, objections, disqualifications, refunds, pertinent incidents, general details etc., Film Reviews, Races, Claims)

#### Office:

09:30 – Received a call from Trainer Mark Casse inquiring about yesterdays' disqualification in the Mazarine Stakes. Mark did not dispute the disqualification through the stretch but did ask for an explanation about the incident into the first turn. We offered our position and while he may not agree completely, he appeared satisfied with the conversation.

### Film Reviews:

The Mazarine Stakes involving Jerome Lermyte, David Moran and Eurico Da Silva for two separate interferences. David said going into the Club House turn I can see he wants over and I was prepared to let him go, but then he just closes it on me. If he waited a stride or two there would be no problem. Jerome said he left room in there but he did shave David going into the turn. In the second incident at the top of the stretch, Eurico said I see him coming out but I'm off his right flank, he keeps coming and I'm pulling out then there's an extra movement by him and I'm on heels, had to check hard and take to the inside. Jerome said yes he went out but he's in front and can go where he wants, blamed Eurico for pulling his horse in behind him, did not believe he did anything wrong. After review it was decided that Jerome be levied a three day suspension.

## Races:

Race 1 - Clear

Race 2 – Stewards Inquiry into the start involving #3 "Trinity Thundah" ridden by Sunny Singh and #4 "Sparkish" ridden by Simon Husbands. Sunny said he's a bad gate horse and have had trouble with him before, went out first jump, did my best to straighten him. Simon said yes, the inside came out into him hard first jump, not much the rider could have done, but I had to check. After review we disqualified #3 from first and placed it fourth behind #4.

Race 5 - #1 "Spanish Ballerina" dropped her rider Leo Salles during the post parade and ran off the racing surface. Scratched by the Stewards.

Race 6 – Tongue tie came off the #9 "Fiery Bear" ridden by Leo Salles and the gate crew were unable to get it back on, runs with out. Reviewed the run down the backstretch which was a bit rough, unable to hang it on any one individual.

Race 7 - #5 "Itstartswithadrink" ridden by Leo Salles was scratched by the official veterinarian at the gate prior to the race. Clear

Race 8 – Tqhe Cup & Saucer Stakes - #3 "Northern Thunder" with Kazushi Kimura was away awkwardly. Did observe a number of riders that were borderline over the head with their crops, Notice of review sent to Jockeys Quarters.

Race 9 - #1 "Distinct Passion" ridden by Ismael Mosqueira did not negotiate the turn and took three horses out with him.
