Spoke to all the out of town riders about our urging rules and associated penalties.

Film Reviews:

Review of yesterdays' seventh race with Kazushi Kimura and Carl DeFreitas. Carl said the video speaks for itself, he came over very quickly and almost put me over the fence, clipped his heels, he wasn't clear and put me in a bad spot. Kazushi felt he was clear and that Carl should have yelled and let him know, would have pulled off if he heard Carl yell. After review, it was decided the incident warranted a three day suspension be handed down to Kazushi. Days to be determined.

Races:

Race 1 – After going official we received a call from Gary Boulanger who was aboard the second

place finisher #1 “Frac Attack” stating his Trainer Nick Nosowenko wants to claim foul against the winner. We advised the race has already been made official and that we had looked at the incident in question through the lane and found no reason for a placing. Gary agreed saying his horse was getting in with him, which made it look worse than it was.

Race 2 – Rider Claim of Foul (COF) by Steven Bahen aboard #12 “Wilburnrubber” against Leo Salles on #8 “Deed’s Legacy” for interference at the top of the stretch. Steve said he was leaning all over me, trying to get out, kept bouncing all down the lane, just trying to hold my ground. Leo said he was bouncing me, bouncing me all through the stretch, what’s with that? After review, it was decided that both parties contributed to the situation and the COF was disallowed.

Race 4 – Rider Claim of Foul (COF) by Justin Stein aboard #1 “Mambointheforest” against the winner #3 “Alicia’s Kid” ridden by Simon Husbands for interference in late stretch. Justin said he wasn’t sure but felt Simon may have hit his horse across the face approaching the wire. Simon said they were very close together and had to go straight down with his whip in order to hit his horse, does not believe he made contact with Justin’s horse. After review, the video was inconclusive and we could not see any contact or reaction from the horse, COF was disallowed.

Jose said nothing he could do, four of us going into that first elbow and something had to give, can’t pin it on anybody, just one of those things. After review all involved were far back and no action was taken. Observed two riders using the crop well above the head, Jockey Lukas Delozier aboard #6 “Durance” who finished second received a monetary penalty equal to twenty percent of his earnings and Andrea Atzeni aboard #7 “Imperial Charm” which finished fourth was also fined.
