Race 2 – Stewards Inquiry regarding the first turn and four horses in a chain reaction starting from the inside out. #3 "Nonplusultra" with Eurico Da Silva who said his horse blew the turn and was giving him a hard time, doing it again on the second turn. Leo Salles aboard #2 "Bokermin" was just off Eurico's heels and forced out into Kazushi Kimura aboard #6 "Keep Your Word" and that one out into #7 "Love of Mine" ridden by Steven Bahen who loses both stirrups in the

process. As we felt it was initiated by Eurico and his mount which finished last, there was no action taken. Second Stewards Inquiry and Rider Claim of Foul (COF) by Leo Salles aboard #2 "Bokermin" against #5 "Wings of Victory" ridden by Jeffrey Alderson for interference during the stretch run. Jeffrey said his horse went in with him a bit but felt Rafael Hernandez aboard #1 "Native Prince" came out more. Leo Salles said the outside horse #5 came down and bumped me in behind the #1 and I caught that ones heels making my horse stumble badly. Thought I could have won the race. Rafael said he was straight down the lane and felt my horse lose it's action in behind, wasn't sure what happened but my horse lost momentum and I feel cost me the win. After review, we disqualified #5 from first and placed it third behind #2.
