**Report on day's Events:** (Backstretch - accidents, fines, suspensions, objections, disqualifications, refunds, pertinent incidents, general details etc., Film Reviews, Races, Claims)

### Office:

Owner Joy Elkins attended, asked when the foal certificate of the horse Triglav would be eligible to be released from the race office. Horse was claimed at Woodbine, papers must stay in Ontario for the required 90 days as per TB rule 12.08.

Trainer Sherry Vanden Berg informed us that her trailer had no lights or brake lights and would not be here today. She has two horses slated to participate in the 4th and 9th races. The horses will be Steward scratches but she must provide proof of the trailer being fixed or the parts purchased to fix it.

Trainer Dominic Polsinelli had entered the horse Thunder Point in today's 10th race. Checked original entry, horse was entered as an L1. He had submitted Form 1 to be entered into the program and on the QLP list, there is a 14 day waiting period to race. Once he submitted the form he made his horse ineligible regardless of when he entered as per TB Rule #36.01.03. Mr.

AGCO personnel here today to provide information on IAGCO moving forward. Spoke to some of the changes and fielded questions.

Race 2, #2 Show Me The Prize, C. Husbands, 5<sup>th</sup>, checks into far turn as the room on the inside diminishes when #5, Perfect Road tightens it up on the rail. #2 beats #5. #7 Spring Forward backed away on the far turn and was eased. Rest ok

Race 3, #6 Petite Amy bore in at start made contact with #5 Jezebel Jones, rest ok

Race 4, clear

Race 5, #1 Transfer Pricing and #4 Rightfromthe Gecko on advisement of the Official Veterinarian were scratched. #6 Quality Brew off poorly. Rest ok. Jockey Helen Vanek cited for possible urging violation through the stretch. Upon review, Ms. Vanek does use her crop in an excessive manner by the amount of times she makes contact with her mount from the top of the stretch with her crop. Spoke with Ms. Vanek, waived her right to a review and issued a \$300.00 monetary penalty and 1 day suspension of October 19, 2019.

Race 6, Stewards Inquiry regarding start of #4 Abogada, upon review of front tower and pan camera angles, speaking with the starter and rider, #4 does not receive a fair start and a complete refund ordered. Rest ok.
