Mr. Seebah did admit to a mistake regarding the call and was issued a monetary penalty in the amount of \$200.00, for giving two first calls in a race for one rider. TB ruling #11325

Trainer John Mattine attended and was provided a disclosure package, 19-537, fail to report horse death.

Trainer Paul Buttigieg was informed of a monetary penalty of \$300.00 for entering an ineligible horse, Super Chocolate, necessitating a scratch from the 10<sup>th</sup> race November 9<sup>th</sup>, 2019. TB Ruling #11326
