### Film Reviews:

Race 4, Nov. 13, 2019. Leo Salles and Dave Moran. Irwin Driedger as rep.

Mr. Salles intimated that he had some trouble with vision due to the snow and thought his horse was running straight. David Moran stated that he had to check and lost his momentum, could have finished closer.

L. Salles issued a three day riding penalty, days to be determined, was informed.

Race 4, Leo Salles, urging, excessive, more than three strikes in succession through stretch. The view on the DVD replay was not as clear as our view in the stand. I. Driedger to attend stand to review later.

Mr. Driedger attended the Steward stand following the 2<sup>nd</sup> race and reviewed the stretch run regarding Mr. Salles and his urging. Utilized the lower pan camera angle which was very clear to

the infraction of excessive use of the crop.

Mr. Salles issued a one day riding suspension and a monetary penalty of \$300.00, second offence within a calendar year. Day to be determined was informed.

Upon review of the front tower and upper pan camera angles #1 does go in and interfere with the #3 on the rail in the vicinity of the 1/16<sup>th</sup> pole. #3 does have to check and loses ground to fourth and then comes back on to finish 3<sup>rd</sup>. #1 finished second placed third for interference.
