A correction regarding the refunded horse in yesterdays' 6th race. The Senior Race Official report indicated that the #10, Takota, would receive second place purse earnings. This is incorrect as the horse was deemed to have been advantaged as the gate stall doors open prematurely to the starter releasing the field, #10 Takota pops the doors, #10 is disqualified and does not receive any purse earnings. Association and Trainer D. McClachrie were informed.

Trainer Lorne Richards informed us that Stuart Simon will be the trainer of record for True North Stables.

Film Reviews:

Race 2, November 15, 2019. Jockeys Keveh Nicholls and Leo Salles. Irwin Dreidger as rep. K. Nicholls aboard #1 Big Rocket Man is out in the 3 path turning for home, #3 L. Salles is inside as #1 does come in, #3 has to check and loses its position necessitating the #1 to be demoted to third from second.

Mr. Nicholls assessed a three day riding suspension, November 23, 24 and 27, 2019

Race 1, #4 Kaili's Big Boy stumbled start, rest ok. E. DaSilva cautioned on raising up in the irons prior to the finish.

Race 2, #6 Giant Mine bore out at start and lugged out into first turn, rest ok. Jockey M. Buchanan cited for a possible urging violation. More than the acceptable amount of times you can make contact with your horse with your crop in succession.

Race 4, #3 Peut Etre off awkwardly, rest ok. Jockey Sunny Singh cited for a possible urging violation, making contact with his mount with his crop in the upward position. Notice of Review for Singh.
