Race 4 Saturday November 16, 2019. Sunny Singh, Irwin Driedger as rep. Urging, making contact with his mount with his crop in the cocked, upward position. Mr. Singh felt that he was having problems with his horse through the stretch, she was lugging in, and he was merely trying to keep the horse straight. We informed him that it is more prevalent to steer with the reins not the crop.

Mr. Singh was issued a monetary penalty of \$200.00 for the offense. Was informed

Race 1, #4 Mocal stumbled slightly at start and was eased through stretch. Spoke with jockey Justin Stein who stated the horse was having issues after stumbling at the break. Rest good

Race 2, clear

Race 3, #1 Bahamian Park bore out at start, made contact with #2 Say It Again Artie, who shied from the contact, rest ok

Race 4, #1 Optimystical, Wilson, checked on the inside as the horses crossed over on to the main track from the chute, spoke with jockey Alan Garcia and Emma Jayne Wilson, Wilson intimated her horse was hesitant and basically checked itself, Mr. Garcia felt he left enough room. Jockeys A. Garcia and J. Alderson issued a caution regarding urging, when they pulled the crop over and using it to make contact once in the upward position. Rest ok.
