The Stewards have recorded the following note regarding the newly implemented AGCO Directive 4-2019, urging rules 9.27.07 (d) and (e) where as a jockey cannot make contact with their crop in the 'cocked" position, or upward position, with their mount. There has been no noticeable or visible signs of safety with regards to the Jockeys riding in today's races. There have been no reports from the Official Veterinarians or Test Barn personnel regarding the welfare of the horse, cuts or welts.

Film Reviews:

Race 2, November 22, 2019. Leo Salles, I Driedger as rep. Urging, using crop in the cocked position when making contact with his mount. Mr. Salles iterated that the horse is difficult to ride and lugs out and was trying to stay in his position as the horse drifted, has a funny bit in its mouth. Stated he made a mistake. We said that as a rider you are to steer your horse with the reins and encourage forward momentum with the crop and use it in the manner of which the rules provide for. Third offense this year for urging, 3 day riding suspension and a \$500.00 monetary penalty. days to be determined.

Race 2, #4 Storm Gauge popped the starting gate stall doors prior to the last horse being loaded. Starter closed doors and released field in a fair start. #4 was eased through stretch. Spoke with rider Civachi who stated he felt that the horse was short on fitness. Reviewed the run down the backstretch regarding #7, Stormy Vision, J. Alderson, 8th. It appears his horse catches a heel of the #6 Dance Ready, A. Garcia, 9th, and stumbles. Spoke with Alderson, he stated the #6 was having issues outside of him and checked and came over slightly but was not sure if it was #6 or #2 to the inside that he caught. No violations

Race 3, #6 Malibu Dawn appeared to lug out through stretch, rest ok

Race 4, #4 Trail Blazing Essa bore out at start, #5 Willed stumbled slightly at start, rest ok

Race 5, clear

Race 6, #1 Carrissimo was off a step slow, #8 English Illusion was fractious from the start to the first turn, rest ok

Race 7, #1 I Have Feelings off a step slow, #3 Dreamin On a Cloud was eased through the stretch, rest ok..

Race 8, Kennedy Road Stakes, #6 Pink Lloyd off a step slow, prevailed, rest clear

Race 9, Coronation Stakes, awkward start for #7 Muskoka Gold, rest ok

Race 10, Stewards inquiry, #5 Blues Roar clips a heel and stumbles, after start, reviewed with the back tower and upper pan camera angles. Spoke to #5 C. Husbands and #4 Raphael Hernandez which was eased. It was inconclusive as to where the pressure came from, inside or out and no changes were made to the order.
