### **Film Reviews:**

Race 1, November 24, 2019. Sahin Civachi, #6 E. Ramsammy, #4 L. Salles and #5 R. Hernandez. I. Driedger as rep. There was no back tower shot available. #7 S. Civachi 3<sup>rd</sup> comes in and creates a chain reaction to riders on #6 #5 and #4, having to steady and check their mounts about the 5 ½ furlong marker, as he is not clear. #7, Sent From Heaven was third placed seventh. Mr. Civachi issued a 3 day riding suspension. Days to be determined.

Race 3, #7 bore out turning into the stretch and was ease, did not finish. Spoke with Jockey J. Alderson who stated the horse was making a run on the outside and threw its head and backed up. Rest ok.

Race 6, #5 Ann of Cleves off a step slow, rest ok.

Race 7, #1 Modus Operandi threw its head at start and reared making it slow, #5 Missworldvalenzuela eased into stretch, spoke with jockey Stein, horse was locked on left line. Rest ok.

Race 8, #1 Just Bling It, on advisement of the veterinarian was scratched at the gate, refund of \$125,089, #5 Wedding Ring off a step slow, rest ok

The Stewards have recorded the following note regarding the newly implemented AGCO Directive 4-2019, urging rules 9.27.07 (d) and (e) where as a jockey cannot make contact with their crop in the 'cocked' position, or upward position, with their mount. There has been no noticeable or visible signs of safety with regards to the Jockeys riding in today's races. There have been no reports from the Official Veterinarians or Test Barn personnel regarding the welfare of the horse, cuts or welts.
