Owner Greg Samulak attended and was provided the required settlement agreement document for his spouse J. Samulak, will return signed tomorrow, J. Samulak has agreed to the penalty of a 15 calendar day suspension, Dec. 5th through the 15th, 2019 and the first 4 days of the 2020 Woodbine racing season and a monetary penalty of \$1,000.00 as a result of a Class 3 Acepromazine positive result from the horse "Flat Out Fabulous" which finished second in the 8th race on November 13, 2019.

Trainer Daniel Vella provided a signed settlement agreement document for a class 4 positive, Meclofenamic acid, analysis from the horse Via Ann which finished 1st in the 1st race on November 6, 2019 and has been issued a 5 calendar day suspension, Dec. 9 through 13, 2019 and a monetary penalty in the amount of \$500.00.

Exercise/Pony person Ruben Hurtado-Peralta attended as a result of a report from course Marshall Katy Morrison on Tuesday November 26, 2019. Mr. Peralta did admit to taking his horse on the track when ordered not to and stated that he was permitted on by the attendant and the attendant closed the gap after he went through. Reserve decision.
