- Judges held a meeting with Racing Manager Greg Gangle and driver Colin Kelly regarding some concerns the Judges had in races from Tuesday December 3/19 between Kelly and Marc St Louis. The Judges stressed the importance of safety for all participants and acting in a professional manner while on the racetrack.
- Mario Baillargeon Dropped appeal of SB 49365 \$300 monetary penalty and 5 day driving suspension, Dec 21-23, 26, 27. SB 51035.

Race 2 – Inquiry X 2 – Reviewed racing in the stretch and at the half.
