Assistant Trainer Joy Cooper for Graham Motion enquired about saddling horses for other trainers while she is here with their horses. As per rule 6.01 she may only saddle for the trainer has employed her in that capacity. The Stewards may only waive under exceptional circumstances.

Trainer Dominic Polisinelli, conduct following the 7th race December 13, 2019, issued a \$100.00 monetary penalty TB Ruling #11365

Trainer Lenore Dubois attended to discuss a rider change for Malta Manors Stables horse Where's Anthony in the 13th race tomorrow.

Prior to the 3rd race, a call was received by Trainer Sid Attard, he stated that he entered the horse Northern Thunder with an equipment change of Blinkers off, we checked with race office and the original entry submitted by Mr. Attard, there was no indication of a request for the change. Was denied without sufficient evidence.

Races:

Race 1, back tower obscured by the heavy snow, upon review of the upper pan #2 Bells of War off a step slow, #3 Takota appeared to stumble, rest ok

Race 2, #4 I Am I Said lugged out into the first turn, #8 Foxy Power eased through the backstretch and did not finish, rest ok

Race 3, Display Stakes, delay due to track maintenance, track was power harrowed, 38 minute delay. #5 Red Mercury trailed and was eased through the stretch, rest ok. Following the 3rd race, Jockey E. DaSilva was excused from the remainder of his mounts. The jockeys asked the Stewards to attend the Jockey quarters while they voted upon continued racing. The vote was in favor of not continuing and the races were cancelled. All parties notified.

Mutuel handle: \$833,590.

The Stewards have recorded the following note regarding the newly implemented AGCO Directive 4-2019, urging rules 9.27.07 (d) and (e) where as a jockey cannot make contact with their crop in the "cocked" position, or upward position, with their mount. There has been no noticeable or visible signs of safety with regards to the Jockeys riding in today's races. There have been no reports from the Official Veterinarians or Test Barn personnel regarding the welfare of the horse, cuts or welts.
