### Races: Opening Night for the 2020 Racing Season

1. Reviewed the break by #1 ZARONIA SEELSTER (Robbie Robinson) before the start; no interference and no violation of the breaking rule by #1 who qualifies for breaks (trainer notified). Driver of #4 QUICKCALLBLUE CHIP, Ryan Guy, cautioned regarding his urging in the stretch. Clear.
  2. Recall due to broken equipment (martingale) on #2 UPVOTE HANOVER. Inquiry on #2, who broke before the start, concerning possible broken equipment; upon review it was determined that #2 did have broken equipment (martingale) before the start (charted with an equipment break and finished with broken equipment, refund: \$6205. Clear.

5. OK JASMINE #4 did break before the start but did make it back up into proper starting position and was therefore not charted with a break. Clear.

9. Reviewed the break by #3 SANTANNA TONY (Marie-Claude Auger) after the start; while off stride #3 did cause interference to #5 and #7; no placing necessary as #3 finished 9<sup>th</sup> (last). Clear.
