- 1. BETTER THAN MEN #1 suffered broken equipment (martingale) after the ¾ mile pole and finished with broken equipment. Clear.

- 3. Reviewed the break by #3 STORMONT MUFFIN (Ryan Guy) before the start, #3 was inside the fair start pole and did receive a fair start. Clear.
- 4. Clear.
- 5. Inquiry and driver's objection, #9 EMOTIONS DURABLES (Tyler Jones) who finished 6th against #4 STPATTYSDAY (Pascal Berube) who finished 4th; Mr. Jones stated that after the start #4 hooked his wheel causing his horse to break which was not supported by the video, objection disallowed.

Reviewed racing before the ¾ mile pole where #8 LESTENPERCENT (Paul Lafromboise) did bear out into #2 GOLDEN DYNAMITE (Guy Gagnon) causing #2 to break (charted with an interference break) and wrecking the right sulky wheel of #8 due to the contact; #8 pulled up and did not finish. Paul Lafromboise was adjudged guilty of violating AGCO rule 22.05.01(a) (bear out into another horse) and assessed a three day driving suspension to be served 14-16 June, inclusive (SB 1020135).

- 7. Reviewed the break by #3 SHINE A LIGHT (Jacques Beaudoin) who finished 5th before the ¼ mile pole; #3 broke, went inside the pylons; no violation of the breaking rules. ITS PLAYOFF TIME (Emil Toth) #9 finished distanced and was examined by the AGCO Official Veterinarian after the race (asymptomatic), #9 qualifies for performance (trainer notified). Clear.
- 8. NATIVE TOWN (Pascal Berube) #1 suffered broken equipment (hopple) before the ½ mile pole, pulled up and did not finish. Driver of #4 BLACKJACK BEAUSOLEIL, Eric Beausoleil, was deemed guilty of violating AGCO rule 22.03 (j)(vii) (failure to come into position and remain in position behind the starting gate) and assessed a monetary penalty of \$100 (ruling will be written up tomorrow). Clear.
